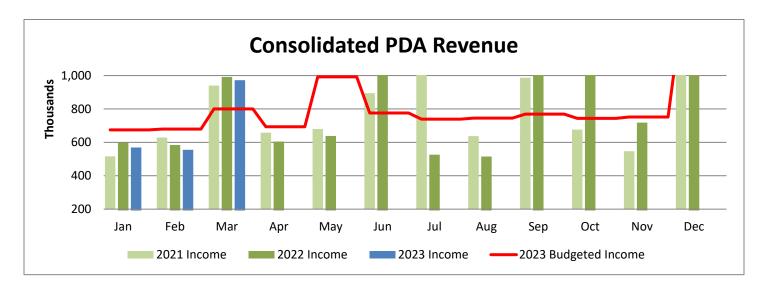

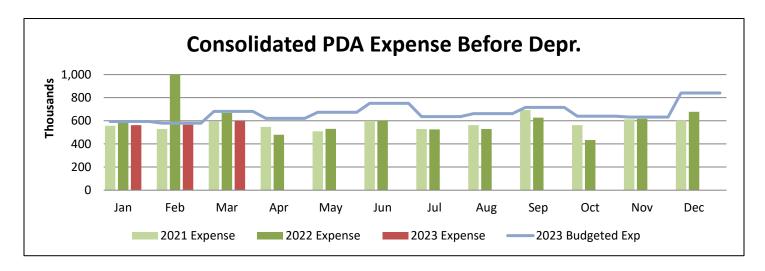

### SCIDpda Consolidated - Q1 2023 Financial Summary

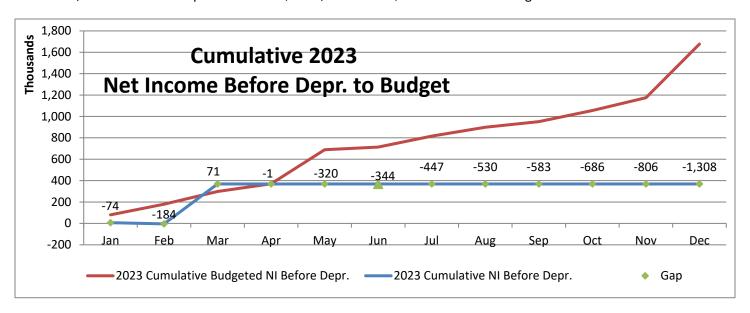


Total Revenue was \$57K unfavorable to budget for the entire organization, largely due to 13<sup>th</sup>&Fir related budget and expenses. Total Service Income was \$29K unfavorable to budget, \$13K due to 13<sup>th</sup>&Fir staff not being billable to the property until move-ins commence mid-May and \$13K due to Management Fee Revenue, the latter being offset by a favorable variance in Management Fee Expense below and due to a late March rent payment from ICHS that was subsequently collected in April along with their April rent payment. Grant Program Expenses, which are listed under Revenue as an offset to Grant Income, were \$18K unfavorable to budget, \$15K of which was 13<sup>th</sup>&Fir leasing expenses that were covered by a Bank of America Grant recognized in 2022. Due to GASB, Grant income and expenses will not offset one another in the same year unless the grant is both purpose and time restricted.

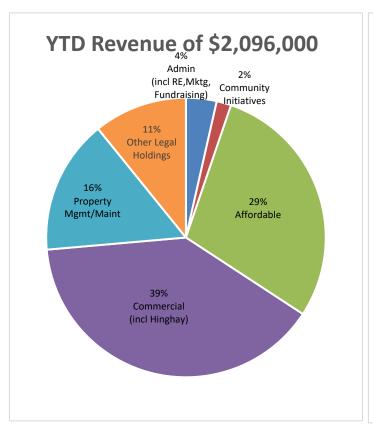


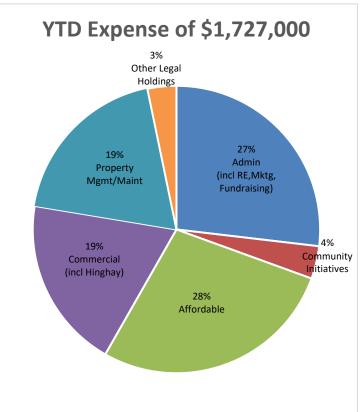
Total Expense was \$128K favorable to budget for the entire organization. Salaries were \$112K favorable to budget due to delayed hires in Admin and Property Management & Maintenance. Other Admin Expense was \$26K unfavorable to budget, with a \$23K unfavorable variance in Computer Hardware and Maintenance Expense due to the cyber attack we experienced; an insurance claim has been filed. Management Fee Expense was \$15K favorable to budget and offsets the unfavorable variance in Management Fee Revenue above. Total Maintenance was \$13K favorable to budget, with an \$11K favorable variance in Commercial Maintenance WOs and Maintenance — Other Vendor Expense. Total Utilities was \$11K unfavorable to budget, with a \$7K unfavorable variance in Affordable Natural Gas and \$6K unfavorable variance in Affordable Electricity. And Total Other Expense was \$22K favorable to variance, \$16K in In-Kind Expense due to the delayed hiring of Joseph's Assistant, whose salary gets donated in-kind to CIDPDA and is offset by In-Kind Income.

As a result, our NOI before Depreciation was \$369K, which was \$71K favorable to budget.
