- 1. The above recitals are hereby incorporated into these Resolutions.
- 2. That SCIDpda hereby ratifies the formation of Broadpine LLC.
- 3. That SCIDpda, as the sole member of Broadpine LLC, is hereby authorized, empowered and directed to enter into, execute, and deliver the amended and restated operating agreement of General Partner ("Operating Agreement"), and all such documents as may be required or advisable to be admitted as a member of General Partner, including but not limited to the documents listed on the attached Exhibit A (collectively, the "Transaction Documents"). The Authorized Representatives (defined below) are hereby authorized to finalize the terms and conditions of the Transaction Documents.
- 4. That SCIDpda, as the sole member of Broadpine LLC, and as the sole member of a member of General Partner, is hereby authorized, empowered and directed to enter into, execute, and deliver all such documents as may be required or advisable for the Equity Investment, including but not limited to the Transaction Documents. The Authorized Representatives are hereby authorized to finalize the terms and conditions of the Partnership Agreement, including the final equity investment amount, and any documents related to the Equity Investment.
- 5. That SCIDpda, as the sole member of Broadpine LLC, and as the sole member of a member of General Partner, hereby authorizes, empowers, and directs Housing Owner to enter into, execute, and deliver all such documents as may be required or advisable to obtain financing from the Financing Providers, including but not limited to the Transaction Documents. The Authorized Representatives are hereby authorized to finalize the terms and conditions of the agreements and documents entered into by Housing Owner and related to the financing provided by the Financing Providers, including but not limited to the final loan amounts.
- 6. That SCIDpda is hereby authorized, empowered, and directed to serve as sponsor of the City Loan, and is further authorized, empowered, and directed to enter into, execute, and deliver all such documents as may be required or advisable for the City Loan, including but not limited to the Transaction Documents. The Authorized Representatives are hereby authorized to finalize the terms and conditions of the City Loan, and any documents related to the City Loan.
- 7. That SCIDpda is hereby authorized, empowered, and directed to enter into, execute, and deliver the Priority and Subordination Agreement, as may be needed to subordinate its interests in the Project to the Financing Providers.
- 8. That SCIDpda is hereby authorized, empowered, and directed to serve as co-developer of the Housing Project, and to enter into, execute, and deliver the Development Fee Agreement between Housing Owner, SCIDpda, and CRH.
- 9. That SCIDpda is hereby authorized, empowered, and directed to serve as the guarantor under, and negotiate, enter into, execute and deliver, the guarantees listed on the attached Exhibit A and such other documents as may be required by the Financing Providers.

10. That SCIDpda, in its applicable Capacities, is authorized, empowered and directed to undertake such further acts and to execute and deliver such other documents as may be deemed reasonably necessary or proper in order to carry into effect any of the provisions of these Resolutions.
